Program Description: This one-day workshop will provide updates on HIPAA compliance issues for local health departments. The workshop will begin with a “back to basics” overview of the HIPAA regulatory landscape and HIPAA learning resources, followed by more detailed consideration of core topics including hybrid entity designation, breach response, individuals’ right of access to their protected health information (PHI), and disclosures of PHI to law enforcement.
