

MEETING THE DEA REQUIREMENT OF THE MATE ACT

Starting January 2023, all DEA-registered practitioners are required to participate in eight hours of training in addiction medicine. This Addiction Medicine Series meets the requirements set forth by the DEA and provides participants a broad overview on addiction treatment. This series provides education on a variety of key topics in addiction medicine, including inequities in addiction, impacts of stigma, basics about addiction treatment, integrating addiction treatment in the primary care setting, and treatment of substance use in special populations including the adolescent population, those with mental illness and those with chronic pain.
